The terms and conditions contained in those forms are the only terms and conditions acceptable to Marth and no additional terms or different terms shall form the basis of a contract between Marth and Customer.
2. In consideration of extending credit to Customer, Customer and guarantor hereby personally guarantee payment on this account for all amounts due and owing on said account. This obligation shall be joint and several between the guarantor and Customer. The liability of Customer or guarantor shall not be affected or prejudiced by the additional acceptance of a note or evidence of indulgence or agreement for time payments granted to the guarantor or Customer. Guarantor hereby waives demand for payment, presentment for payment, protest, notice of protest or diligence.
